### Application for a carrier licence

#### Licence for whom?

You only need to apply to Brussels Environment for a licence if you transport animals as part of an economic activity over a distance of more than 65 km and if your company's head office is located in Brussels.

## How to apply for a licence?

**For short journeys - Type 1 licence** (more than 65 km, less than 8 hours with a border crossing or less than 12 hours on national territory), you must:

- Complete the application form;
- Pay a lump sum of 75 euros onto account:
  - o IBAN BE14 0912 3109 8283 under the name of SPRB (Brussels Regional Public Service)
  - Address: 80 Rue du progrès, 1035 Brussels
  - Communication: "TRSP1 + name"
- Provide us with photos of the vehicle(s) concerned (interior and exterior not internet images of the same model);
- Provide us with evidence that you and your staff are competent to transport and handle animals;
- For the transport of cattle, sheep, goats, pigs, horses and poultry a professional certificate of competence must be provided. If you don't have one, you need to be trained. For French-speaking carriers, you can find information on the CER website (see link at the bottom of the page). For Dutch-speaking carriers, on the DGZ website. These institutions will provide you with the certificate after passing a test. Please note that certificates of professional competence for the staff of companies authorised in Brussels are only valid for 5 years.
- Provide us with proof that the vehicle has the appropriate equipment for the species transported;
- Provide us with your operational procedures / good practice guides (vehicle preparation, animal control/handling, etc.);
- Not to have committed any infringement of Community or national legislation on animal protection during the 3 years preceding the date of application.

**For long journeys - Type 2 licence** (more than 8 hours with border crossing or more than 12 hours on national territory), you must:

- Complete the application form;
- Pay a lump sum of 75 euros into the account:
  - IBAN BE14 0912 3109 8283 under the name of SPRB (Brussels Regional Public Service)
  - o Address: 80 Rue du progrès, 1035 Brussels
  - Communication: "TRSP2 + name"
- Provide us with evidence that you and your staff are competent to transport and handle animals:
- For the transport of cattle, sheep, goats, pigs, equines and poultry a professional certificate of
  competence must be provided. If you don't have one, you need to be trained. For French-speaking
  carriers, you can find information on the CER website. For Dutch-speaking carriers, on the DGZ
  website (see link at bottom of page). These institutions will provide you with the certificate after
  passing a test. Please note that certificates of professional competence for the staff of companies
  authorised in Brussels are only valid for 5 years.

- Provide us with proof that the vehicle has the appropriate equipment for the species transported;
- Provide us with your operational procedures / good practice guides (vehicle preparation, animal
  control, etc.) and in particular the procedures for monitoring and recording the movements of the
  road vehicles under your responsibility as well as the possibility of contacting the driver at all times
  during long journeys;
- Provide us with your emergency procedure;
- Provide us with proof of a navigation system if you are transporting non-Studbook horses, cattle, sheep, goats and pigs;
- Not to have committed any infringement of Community or national legislation on animal protection during the 3 years preceding the date of application.
- Have a certificate of approval for each of your vehicles: this certifies that the vehicle used complies
  with the conditions of transport relating to animal welfare.

In order to obtain a certificate of approval as part of a new application for authorisation or for any new vehicle within your existing business, you must:

- Complete the carrier licence application form;
- Pay a lump sum of 25 euros per vehicle onto account:
  - o BE14 0912 3109 8283
  - o Service Public Régional de Bruxelles,
  - o Rue du progrès 80, 1035 Brussels.
  - Communication "TRSP2 + name"

An inspection of the vehicle(s) must be carried out prior to the granting of your licence or your certificate of approval if you are already in possession of a valid licence.

These licences are strictly "animal welfare" licences. Check with other authorities for any other legal requirements.

In order to be **compliant from a health protection point of view**, please fill in the <u>AFSCA form</u>.

### Follow-up of your licence / certificate of approval file

Within one month of submitting your application for a licence or your application for a certificate of approval, Brussels Environment will send you an acknowledgement of receipt confirming whether or not your file is complete.

The licence is issued within 4 months of the submission of the **complete** application. An application for renewal of your licence should therefore be submitted between the 7th and 4th month before your licence expires.

Any modification or cessation of activities or any change of contact details must be notified to Brussels Environment without delay either electronically or by post.

The validity of a carrier licence and a certificate of approval is 5 years.

  - Certificates of accreditation valid for all means of transport by road to be used for long journeys;
  - Contingency plans;
  - Evidence of the use of a logbook;
  - The following procedures:
    - Procedures for carriers to monitor and record the movements of road vehicles under their responsibility and to contact the drivers concerned at all times during long journeys
